In areas where 1000L of CP Cleaner is stored appropriate signage must be in place. When stored appropriately, this product should show no significant degradation for 2 years from the date of manufacture (DOM). Contact your supplier for further information about the use of any product that is older than this.

**DISPOSAL:** Dispose of this product only by using according to the label or at an approved facility. Avoid contamination of any water supply with product or empty container. Triple rinse empty container and add rinsate to spray tank and deliver to an approved recycling depot (eg Agrecovery).

**DIRECTIONS FOR USE**

**CP CLEANER IS A PRE-HARVEST WATER STAIN REMOVER FOR USE ON KIWIFRUIT TO IMPROVE COLOUR, INCREASE FRUIT CALCIUM AND REDUCE PACKOUT REJECTS. CP CLEANER CONTAINS A BUFFERED SOLUTION OF PHOSPHORIC ACID/CALCIUM PHOSPHATE WITH A WETTING AGENT.**

**TIMING:** Apply shortly before harvest (i.e. 1-3 days) in good drying conditions to dry fruit. May be applied to damp fruit, but only in good drying conditions.

**APPLICATION RATE:** 5 litres per 1000 litres of water as a dilute spray. No additional surfactant is required.

**SPRAY RATE:** Use 2000-3000 litres of water per hectare. Increase rate to 4000 litres for difficult conditions (bad staining or dense canopy). Consider split applications in opposite directions through block.

**TRACTOR SPEED:** For best results maintain a tractor speed of between 3-4km/h.

**CLEANING SPRAY EQUIPMENT:** Use before spraying biocontrols, such as Blossom Bless or after use, especially coppers such as Nordox 75WG. For sprayer flushing, use 500mls to 1L of CP CLEANER per 100L of water. Rinse the sprayer with clean water after flushing with CP CLEANER ensuring that all lines are flushed (including nozzles) and that the filter is removed and emptied.

For general external cleaning, 100mls in 10L of water. Brush on and rinse off. If contamination is heavy, increase amount of CP CLEANER used, up to 100mls per litre but ensure rinsing is thorough.
