**Active Constituent:** Contains Nitrogen 10% (as nitrate and ammonium salt), Phosphorous 5% (as phosphate), Potassium 15% (as sulphate and nitrate), Sulphur 13% (as sulphate), Magnesium 0.7% (as sulphate), Calcium 0.3% (as chelate), Iron 0.3% (as chelate), Manganese 0.2% (as sulphate), Boron 0.1% (as boric acid), Zinc 0.1% (as sulphate), Copper 0.04% (as sulphate), Molybdenum 0.02% (as molybdate) as water soluble powders.

- AVO K™ has been specifically designed for fertigation in trees and vines which require chloride free inputs.
- AVO K™ is an NPK highly soluble complex with the addition of Magnesium, Calcium and Trace Elements.

**INJECTION:** To dissolve, add the fertiliser to the water at a maximum concentration of 10kg per 200 litres of water (20:1) and stir until dissolved.

- Rates per tree /vine or area are determined by either consultant or type of fertigation system used to apply and crop requirements.

**DISPOSAL:** This product should be disposed of by use in the manner described on the label, or by depositing it in an approved landfill. Segregation from products of Class 1, 2, 3 and 4 must be maintained after disposal unless the properties of the product have been altered to remove the hazardous properties. Dispose of empty packaging in an approved landfill.
